Real-time currency conversion for various debit currencies added complexity. This was addressed through the incorporation of advanced algorithms and integration with reliable exchange rate providers.

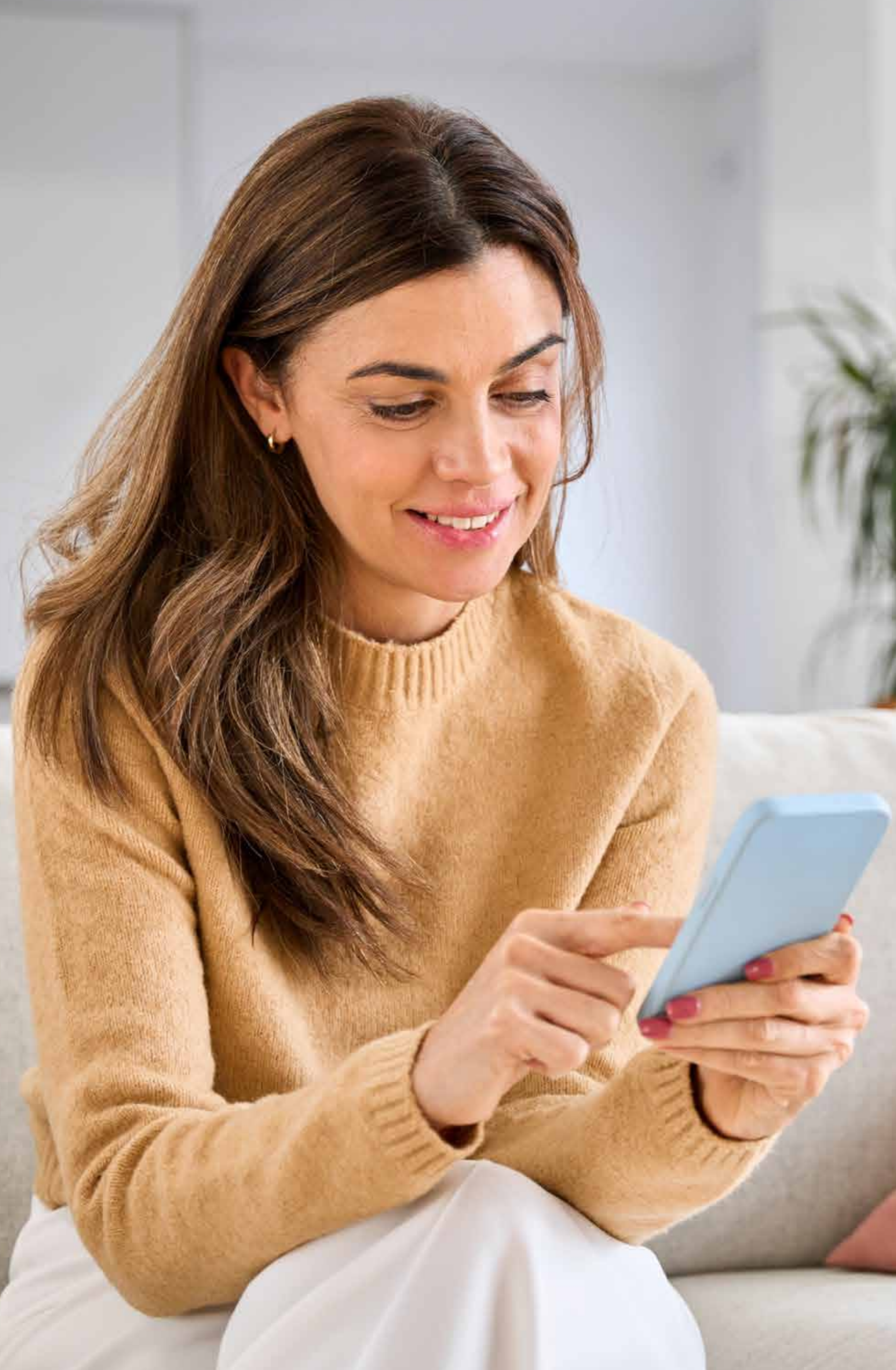
